## **Colorado House advances Hospital Provider Fee plan Denver Post**

The Colorado House passed a change to the state's hospital provider fee Friday that could keep \$700 million a year in the state budget, instead of going to taxpayer refunds. Though the shift drew five Republican votes in the Democrat-controlled House, it appears a long shot to pass the Senate. In the upper chamber, Republicans have been entrenched since the beginning of the session to defend the refunds due under the state's Taxpayer's Bill of Rights.

## **Jon Keyser wins legal challenge, will appear on U.S. Senate ballot**

Days after his once-promising U.S. Senate campaign appeared dead, Jon Keyser won a legal challenge Friday to return to the race and appear on the Republican primary ballot. District Court Judge Elizabeth Starrs issued a ruling that found Keyser's campaign "substantially complied" with the law when he submitted signatures to qualify for the race. The decision is just the latest twist in the roller-coaster contest for the Republican Party's nomination to challenge Democrat Michael Bennet.

## **Colorado Springs politician once again bucks Republicans**

State Rep. Kit Roupe, R-Colorado Springs, was one of five Republicans to vote for a bill Friday that would allow the state to retain millions of dollars that otherwise would have to be returned to voters under the Taxpayer's Bill of Rights.

House Bill 1420 passed 39-26 on Friday and is headed to the Senate, where its success depends on what committee it is assigned to by Senate President Bill Cadman, R-Colorado Springs.

The bill removes from the general fund revenue generated by a fee charged on hospital stays so that money no longer counts toward the TABOR threshold (the point where revenue has grown too fast and money must be returned to taxpayers). The hospital provider fee revenue would instead go to a separate enterprise fund, where it is exempt from TABOR and outside the purview of lawmakers.

## **OPINION: Legislature still needs to act on Colorado condo defects laws**

It's been nearly two years since communities along the Front Range, frustrated by failure of the legislature to help boost lagging condo construction in Colorado, began to take matters into their own hands.

Lakewood was first to act, in 2014. It passed an ordinance to discourage excessive lawsuits by homeowner associations over construction defects and give builders more opportunity to fix problems before litigation begins.

Since then, a number of other locales - including the state's three largest cities - have

followed with their own versions of construction-defects reform.

## **Bill that could weaken Colorado health exchange funding gets Senate approval**

One of the most long-standing critics of Colorado's health exchange pushed a bill through the state Senate on Tuesday that critics warned could cripple or even shut down the online insurance marketplace.

Senate Bill 2, sponsored by Sen. Kevin Lundberg, R-Berthoud, would require Connect for Health Colorado to seek approval from voters in order to continue charging a 3.5 percent administrative fee on all plans sold by insurers who offer products on its exchange - whether those plans are sold on or off of the exchange. Those fees are expected to generate \$24.9 million for Connect for Health in the fiscal year that begins on July 1.

## **Colorado Supreme Court rules state law trumps local bans on fracking**

Colorado's Supreme Court ruled against Front Range cities' push to limit oil and gas development near people Monday, saying state power to regulate the industry trumps local measures, which the court deemed "invalid and unenforceable."

The court overturned Fort Collins' five-year moratorium on fracking within the city limits. Justices concluded it "operationally conflicts" with state law and therefore, under well-established principles, must be pre-empted by the state. It also rejected Longmont's 2012 ban on fracking because it "materially impedes" use of state power.

## **Colorado Suspends 911 Rulemaking Amid Safety, Rules Debate**

Colorado utility regulators are postponing a plan to address 911 outages and security by expanding their authority over the emergency calls.

The Public Utilities Commission on Tuesday indefinitely suspended the rulemaking effort. The governor's office and lawmakers argued it risked overstepping powers granted by the Legislature during telecommunications deregulation in 2014.

The rulemaking - and a bipartisan bill designed to stop it - fueled debate not only over what some called excessive regulation but the reliability of Colorado's 911 systems, which have seen sporadic outages in recent months.

## **Colorado pot industry steps up pesticide fight against regulators**

The Colorado marijuana industry is stepping up its fight against the state's efforts to regulate the application of pesticides on cannabis. After passing in the state House, a bill that would have codified Gov. John Hickenlooper's November executive order - telling state agencies that any marijuana grown with unapproved pesticides is a threat to public safety and should be removed from commerce and destroyed - died in a state Senate committee last week. Those who successfully voted the bill down in the state Senate Veterans & Military Affairs committee described Hickenlooper's vision as "unreasonable" and "unconstitutional."

## **OPINION: Charter schools need proposed legislation**

Colorado's increasingly popular charter schools have come a long way in a relatively short time. Since their bipartisan authorization by a Republican legislature and Democratic governor in 1993, these autonomous and innovative public schools have grown explosively along the Front Range and elsewhere. More than 225 charter schools serve over 108,000 students statewide, including thousands in the Pikes Peak region. They have become a key component of our state's overall education portfolio. Along the way, charters have established a record of academic excellence. While some of the programs struggle and sometimes fail, charters are perennially recognized among Colorado's top-performing public schools. Three charter high schools in our community - Cheyenne Mountain School District's Vanguard School, Academy School District's The Classical Academy and Harrison School District's James Irwin Charter Academy High School - ranked sixth, 10th and 11th, respectively in our state on U.S. News & World Report's latest list of the nation's top public high schools. All of which amounts to an even more impressive feat when one considers that many charter schools and their students make do with considerably fewer resources than their counterparts at traditional public schools.

Under legislation introduced Tuesday, all future sales or leases would require the phrase "Mile High" to be a part of the name. Any signs or other material containing the stadium's name would also have to incorporate those two words.
